Section 4 - City Beer Due to Census

If applying for a city beer license due to census, the successful lottery applicant must pay the department a one-time \$25,000 original license fee and in subsequent years, pay the annual fee for the license as provided in 16-4-501, MCA.

The successful lottery applicant is subject to forfeiture of the license and the original license fee if the successful lottery applicant:

- enters into a concession agreement, as defined in rule, for the license awarded by lottery in the first five years;
- transfers a license awarded by lottery within five years of receiving the license;
- does not use the license within one year of receiving the license or stops using the license within five years.

"Concession Agreement" means an agreement in which an on-premises consumption beer licensee provides the sale and service of alcoholic beverages for a nonlicensed entity.

Section 5 - Declaration and Affidavit

If my application is drawn in the lottery, I understand that I must submit a completed license application and the appropriate fees within 30 days of being notified that I was the successful applicant. I further understand that information concerning ownership on this application must be consistent with the license application and supporting documents or I will be disqualified. For example, if you complete this application as an "individual," and are the successful applicant, your subsequent license application must also be as an "individual."

I declare under penalty of false swearing that I am the applicant or the duly authorized representative of the entity making this application, and that the responses provided, including any accompanying information, are true, correct and complete.
