### Instructions

#### Account Information

- Line 3: This report is due on or before the 45th day after the end of each semiannual period. Under Montana law, penalty and interest apply on all delinquent returns (15-1-216, MCA).
- Line 4: If you are filing an amended return, this box must be checked.
- Line 5: If you are no longer in business, check the box and enter your final day of business here.
- Line 6: If your mailing address has changed, check the box and enter your new address in the space provided. Please provide the mine name, the county where the mine is located, the section, township and range as well as the school district.

**Production** – The tonnages are cumulative for the year therefore once a threshold has been met it may not be used again for that production year.

Here's a simple example to illustrate how this works: The total wet tons produced was 15,000 tons in the first semiannual period, and 25,000 tons in the second semiannual period. On your first semiannual return, you would enter 15,000 tons on line 7 under the column, January – June. On your second semiannual report, you would enter 5,000 on line 7 under the column, July – December, and the remaining 20,000 tons would be reported on line 8.

- Line 7: Enter the number of wet tons produced between 0 and 20,000 tons for the year.
- Line 8: Enter the number of wet tons produced between 20,001 and 100,000 tons for the year. Multiply the number of tons by \$1.66; enter this total in the Tax Due column.
- Line 9: Enter the number of wet tons produced between 100,001 tons and 250,000 tons for the year. Multiply the number of tons by \$1.60; enter this total in the Tax Due column.
- Line 10: Enter the number of wet tons produced between 250,001 tons and 500,000 tons for the year. Multiply the number of tons by \$1.49; enter this total in the Tax Due column.
- Line 11: Enter the number of wet tons produced between 500,001 tons and 1,000,000 tons for the year. Multiply the number of tons by \$1.33; enter this total in the Tax Due column.
- Line 12: Enter the number of wet tons in excess of 1,000,001 tons for the year. Multiply the number of tons by \$1.07; enter this total in the Tax Due column.  
Please provide the total tons produced for the year and total gross value for the year in the box provided.

#### Royalty Interest

- Line 13: Enter the total royalties paid/yielded and multiply by 15%. Enter the tax in the Tax Due column.

#### Total Tax Due

- Line 14: Enter the total amount due (sum of lines 8 through 13). Please reference your federal identification number from line 1 or your account ID from line 2 of the return on the memo line of your check.

*Please note:* Payments in excess of \$500,000 must be submitted electronically. To wire your payment, send the payment to Montana State Treasurer, bank routing #092900383, account #156041200221 by the due date of this return. When submitting payment by wire, please provide third party information: Department of Revenue, taxpayer's name and/or federal identification number, and the tax to which the payment pertains.

Sign the return and provide your title and phone number where you can be reached during business hours.
