

HB123: What does it do and how did it go?

In an effort to properly align all local government budget timelines, HB123 provided 28 additional days for the 56 Montana Counties to complete mill levy requirements and report those to the Department of Revenue (DOR). As a result DOR now has 28 fewer days to use that mill levy data to calculate the tax bill data and return that to County Treasurers billing local property taxpayers.




