

Worksheet IX – Tax Benefit Rule for Recoveries of Itemized Deductions

If you recovered amounts from more than one year, such as a federal income tax refund from 2006 and a casualty loss reimbursement from 2005, complete a separate worksheet for each year. Use the information from Form 2, Itemized Deductions, for the year the expense was deducted.

For example: You claimed a casualty loss as an itemized deduction on your 2006 Montana income tax return. In 2010 your insurance company reimbursed you for the casualty loss. In order for you to determine if any of this reimbursement is taxable in 2010, you will need to use your 2006 Montana income tax return and Table 4 "Standard Deduction" on page 2 of this worksheet.

A recovery is included in income only to the extent the deduction reduced your Montana tax liability in the year deducted.

	Column A (for single, joint, separate, or head of household)	Column B (for spouse when filing separately using filing status 3a)
1. Enter the total of your federal income tax refunds received in 2010 for which a deduction was taken in a prior year. Do not include refundable federal credits or more than the amount of federal income tax deducted on Schedule III.1.		1.
2. Enter the total of all other itemized deductions refunded or reimbursed to you in 2010 that are not included above and for which a deduction was taken in a prior year.2.		2.
<p>Example: In 2007 you deducted medical expenses not covered by insurance. In 2010 your insurance company determined that they should have paid a portion of the denied expenses. They sent you a check. This amount may be taxable because you claimed it as an expense paid by you in 2007.</p>		
3. Add lines 1 and 2.....3.		3.
4. Enter the total Montana allowable itemized deductions for the year that you claimed this deduction. If you took the standard deduction, stop here; your refund(s) is not taxable.....4.		4.
5. Enter any amount previously refunded to you. Do not enter any amount from line 1 or 2.....5.		5.
6. Subtract line 5 from line 4.....6.		6.
7. Montana adjusted gross income for the year you claimed the deduction7.		7.
8. Enter the standard deduction for the year that this deduction was claimed. (The standard deduction amounts for 2009, 2008, 2007, 2006, 2005 and 2004 are shown in Tables 1 through 6 found on page 2 of this worksheet.).....8.		8.
9. Subtract line 8 from line 6. If the result is zero or less, stop here, the amount on line 3 is not taxable9.		9.
10. Enter the smaller of line 3 or line 9.....10.		10.
11. Enter your Montana taxable income for the year the deduction was claimed 11.		11.
12. This is your recovery amount to be included in income for 2010.12.		12.

Standard Deduction Rates

Multiply the amount on Worksheet IX, line 7 by 0.20 (20%) and enter this amount on Worksheet IX, line 8, but not more than the maximum amount reported below, or at least the minimum amount reported below that corresponds with the tax year that you are calculating your tax benefit rule recovery amount.
